 4. Liability Form 2016-2017 (unless on file as of Oct. 2016)
 5. Scholarship Application, if applicable. No more than \$50 will be awarded, and scholarships are limited. Please do not account for a scholarship until confirmed. Go to www.swunityyouth.org for application, found under "Teen Forms."
- **ONLINE REGISTRATION.** Once you have turned in all completed paperwork to your Youth Director, the last step is to register online before April 19th. Your Youth Director will email you the link after your group has turn in the initial paperwork.
- **Complete registration online by April 19th:** It is very important that each participant is registered online by this date. Pre-Rally information will be sent via email to those entered in the online registration system. Please be sure that you enter a correct email address. After April 19th, dietary requests cannot be honored, nor is assignment to a family group or host home guaranteed upon arrival if online registration is not completed. Thank you for your attention to this matter! (If you have not received pre-rally info by April 21st, check your Bulk folder, or ask your Youth Director.)

Note: payment is expected for anyone registered by April 12th. Any cancellations/no shows after this date will not be reimbursed, however \$70 can be applied to a 2017 event.

2016 – 2017 Southwest Y.O.U. Group Agreements

By choosing to attend this SW Y.O.U. event, I agree to do my part to help create a fulfilling spiritual experience for all. I understand my choices not only affect my own experience, but others' in the group as well. My commitment is to support an environment that creates opportunities for spiritual self-discovery, and maintains physical & emotional safety for all. I understand that certain behaviors which may be appropriate elsewhere are not appropriate during this event. *Agreements start once you begin travel with your group, and end after you have returned home or been picked up by parent/guardian.*

In addition to SW Unity Region policies and applicable laws, I willingly agree to:

1. Respect all present, and take reasonable care of the facility and myself.
2. Look for the highest good in all people and situations, and find ways I can both give and receive to make this event a unique and meaningful experience. I will show loving support and gratitude for all facilitators, speakers, and staff. I will not be part of character assassinations, pranks, put-downs or judgments of others or myself. Nor will I offend or degrade others with my language, jokes or music.
3. Be open to, and fully present for, the experience. I will attend required activities on time, give my focus during activities, and stay in designated areas, unless authorized for special leave by Event Staff. I understand that, unless I have secured prior Event Coordinator approval otherwise, I am committing to arrive by the designated time for check-in for this event, and to stay through the posted closing time. From my arrival until closing of the event, I will not operate, or ride in, a vehicle except with Event Coordinator approval.
4. If I have difficulty focusing during any activity, I agree not to disrupt the experience of others, and can quietly seek a sponsor for personal attention.
5. Restrict use of cell phones, Ipods/MP3 players and other personal electronic equipment to personal time & evenings (*unless otherwise authorized by a sponsor due to an emergency*). Electronic games and multimedia devices are not to be used during the event, but may be approved by sponsor for use during travel.
6. Create a safe space for authentic sharing and reflection about one's experiences on their unfolding spiritual path, while eliminating pressure to participate in illegal activities. I will not use this event or my SW Y.O.U. connections to promote, encourage, facilitate, conceal or arrange participation in illegal activities – including but not limited to use or possession of alcohol, tobacco, illegal drugs or other restricted substances; and including weapons, or anything that can be used as a weapon. If I may have difficulty abstaining from restricted activities or substances, I understand it is my responsibility to discuss support needs with my chapter sponsor and Event Staff.
7. Maintain a positive, spiritual intention in all of my personal relationships. I will not engage in sexual activity, unwanted physical contact, or public displays of affection which cause others present to feel uncomfortable. If I am in a relationship with another YOU'er, I agree to put our relationship "on hold" during this weekend. I will engage in friendships only while at this event.

I understand that these agreements are necessary for the group's highest experience, and agree I have a responsibility for protecting the highest interests of sponsors and our churches. I understand my willingness and ability to uphold these agreements are required to participate in YOU activities. If I choose not to uphold them during an event, I understand my participation at this/future YOU activities will be restricted, any event-related fees forfeited, and I can be sent home early at parent expense.
